Here, symptomatic procedure is adopted and seldom name of the disease is pin-pointed but totality of the symptoms is made under consideration. Our present pandemic issue of Corona virus disease (SARS-COV-2/COVID-19) is just like treatment against HIV in the patients of AIDS where symptomatic procedure gave positive results; will certainly help us here too. Here, considering its total symptoms I have mentioned some homeopathic medicines, considering each and every problem displayed by the patient of Coronavirus. It should be kept in mind that this is not a hypothesis but a prescription guide of the Coronavirus disease. In the last part of the paper for the convenience of the reader I have mentioned a typical prescription to cover the major issue of the patients of this disease.

1. INTRODUCTION

Since 1790's Homeopathy is serving mankind. Before the origin of homeopathy and prevalent dominant system of treatment i.e. Allopathic, the medicines are used in material concentration. While in Homeopathy majority of medicines are used in non-material (i-iii) concentration, which are below Avogadro's concentration. (These medicines of non-material concentration possess STRESS-STIMULATING SIGNALS. While the affected cells possess STRESS SIGNALS which have had produced under the stress of disease. while the STRESS-STIMULATING SIGNALS of Homeopathic medicines guide the stressed cells' DNA for Transduction, and the resultant mRNA Translates in the form of protein that defends body accordingly.) Thus, these medicines have no side effects and are safe to use.

Secondly, common homeopathic medicines used for minor issues can work against extremely complicated problems like Cancer, AIDS, Gangrene and etc. And the present world problem i.e. SARS-COV-2/ COVID-19 can be solved by this system of medicines.

I have selected some homeopathic medicines that can help us to fight against SARS-COV-2/ COVID-19.

2. GUIDE FOR PRESCRIPTION

I shall not indulge myself in the symptoms and signs of the disease which are beyond the scope of this article, here, I simply point out that when our immune system or defense is weak this virus attacks on our body and the damage of nervous system is inevitable.

Body defense depends upon the active physiology of liver. Liver physiology can be normalized with *Chelidonium majus*^(iv,vi-xii) Q.

Under the influence of this Virus Nervous system is also disturbed and this disturbance of the patient can be detected by blurred vision, loss of sense of smell (anosmia) and/or loss of sense of taste (ageusia). The nervous system can be protected and retained to normal level by *Stramonium*^(vi-xii) 30, 200, 1000 and *Ambra grisea*^(iv,vi-xii) 3x-6x.

As the name of the disease respiratory syndrome, the respiratory tract of the patient is most affected. It can be protected by *Aconite napellus*^(vi,vi-xii) 6x, 30, 200, 1M, 10M, 50M, CM & LM the potency of the medicine can gradually be increased from 6x to onwards so that benefits from each and every potency can be achieved.

Under extreme respiratory stress the patients are shifted in the ventilators these are not only costly but their availability is another issue. This problem can easily be tested on the patient and can be observed within an hour by repeatedly giving *Carbo vege*^(iv,vi-xii) 30, 200 & 1000.

Ars. album^(iv,vi-xii) 30, 200,1000 and 10M is used to aid respiratory system while the respiratory system is not under severe stress. When Carbo vege is given, *Ars. album* is not used as these are antidote^[R. Gibson Miller(ix)] to each other and cannot be used simultaneously.

Under the stress of this disease Mitochondria cannot produce enough energy due to the lower concentration of cellular Oxygen thus the oxygen obtaining capacity of Mitochondria is enhanced by *Vanadium met*^(vi) 30, 200 & 1000.

Another problem faced by the victim of CoVID-19 is High-temperature or fever and rhinitis. In homeopathy *Sabadilla*^(iv,vi-xii) 30, 200 & 1000 helps

miraculously. If body temperature crosses the limits, then we have *Bellodonna*^(vi,vi-xii) 30, 200, 1000.

The sufferer of COVID-19 faces excessive secretion of mucus with dry cough in the respiratory track. This can be solved by *Dulcamara*^(iv,vi-xii) 6x, 30 & 200 + *Mag phos*^(iv,vi-xii) 6x, 30 and 200.

Another related issue is presence of sticky phlegm in the Lungs. This can be detached and its production can gradually be reduced from the lungs by *Kali bichromicum*^(iv,vi-xii) 30, 200 & 1000 + *Spongia tosta*^(iv,vi-xii) 30, 200 & 1000.

The attack of the viruses on the tissues of various organs of the body creates death and decay is inevitable which results in necrosis of respective cells of the organ. These decaying molecules produce numerous problems in the body. To *reduce this death and decay of the cells and to protect other cells from these decaying neighboring cells* we have *Pyrogenum*^(vi,xii) 200, 1000 & 10M.

The list should be incomplete if we neglect some *tonics* present in homeopathy for solving this trouble. These are *Ginseng quinquefolium*^(vi,xii) Q a nerve tonic that also supports lungs and *Viola odorata*^(vi,xii) Q, opens the alveoli of lungs (while giving these tonics blood pressure of the patients be monitored). The heart of the sufferer is also affected under the stress of disease and it can be observed in the form of poor shallow sound through stethoscope while checking Blood pressure. This can be corrected with *Crataegus oxyacantha*^(vi,xii) Q. This heart tonic not only gives force to the heart muscles and can be observed in form of standard reverberating echoing drum beating sound and it also reduces high blood pressure and patient feels soothing.

The list may become much lengthy if each and every related medicine is mentioned, but I think that these few medicines mentioned in this article can solve the large proportion of the problem.

(If Belladonna is needed to be used due to extremely high temperature than Sabadilla and Aconite napellus should be discontinued. And if Dulcamara is already in use, it should first be antidote by Merc. sol as these are inimical^[R. Gibson Millar(ix)] to each other, without antidote their effects these can damage the patient).
